## LEGAL SERVICES

The new Companies Act 2006 came into force in October 2009 and has changed the duties placed on companies and the many returns and procedures necessary to operate. They include greater responsibilities being placed on Directors and that a Company secretary is now not mandatory for a private limited company. However the secretarial duties still need to be undertaken if the company, and probably the Directors, is to avoid a penalty.

WCA is able to offer a company secretarial service to clients which will also include the provision of a Registered Office, with a prestigious London address. We will maintain the registers, file the annual returns and advise on any other filings necessary.

We can provide legal advice and help, specifically regarding share issues, strike off, new Articles and the end of year procedures.

Some companies will want to protect their name and logo through a Trademark. This can be arranged in Europe or through the many countries that form part of the Madrid protocol.

WCA can arrange to become an Agent for Service of Process where it is authorised to accept service on behalf of a served party. The agreement will be governed by UK law.

## LEGALISATIONS

Documents that are to be sent to foreign countries will often need to be legalised. This legalisation confirms that the signature, seal or stamp of a public official, notary public or other accredited official on a document is genuine.

Where the document is for use in a country that is party to the Hague Convention of 1961, it requires only an UK Government Foreign and Commonwealth apostille (legalisation certificate) to be affixed.

We can obtain all the necessary apostilles and authentications for you quickly and efficiently.
